MEDIA MANIPULATION IS A KEY TACTIC. BY CONTROLLING NEWS OUTLETS, ENTERTAINMENT, AND SOCIAL MEDIA, THEY INFLUENCE PUBLIC PERCEPTION. SPREAD PROPAGANDA TO SWAY OPINIONS. DISCREDIT OPPOSING VIEWPOINTS. PROMOTE SYMBOLS AND MESSAGES THAT EMBED THEIR INFLUENCE SUBCONSCIOUSLY.

LAW 4: DIVIDE AND CONQUER

THE ILLUMINATI ARE BELIEVED TO FOSTER DIVISION WITHIN SOCIETIES—POLITICALLY, RELIGIOUSLY, AND CULTURALLY—TO PREVENT UNIFIED RESISTANCE. SUPPORT CONFLICTING FACTIONS.

1. EXPLOIT EXISTING TENSIONS.
2. MAINTAIN CHAOS TO PREVENT ORGANIZED OPPOSITION.

LAW 5: ESTABLISH GLOBAL INSTITUTIONS

CREATING AND CONTROLLING INTERNATIONAL ORGANIZATIONS—SUCH AS THE UNITED NATIONS OR WORLD BANK—SERVES THEIR GOAL OF GLOBAL GOVERNANCE. USE THESE INSTITUTIONS TO SET POLICIES.

3. IMPLEMENT ECONOMIC CONTROLS.

SURVEIL AND INFLUENCE GOVERNMENTS WORLDWIDE.

THE HIERARCHICAL STRUCTURE AND THE LAWS' IMPLEMENTATION

THE 66 LAWS ARE BELIEVED TO FUNCTION WITHIN A HIERARCHICAL STRUCTURE, WITH THE HIGHEST ECHELONS ORCHESTRATING STRATEGIES THAT TRICKLE DOWN THROUGH SECRET SOCIETIES, INFLUENTIAL FIGURES, AND INSTITUTIONS.

TOP-DOWN STRATEGY
